




2. PHOTO-THERAPY - A creative Dermatosurgery Photography Competition

4. ACS(I) millennials Comic strips - The Dermat Diaries






The questionnaire was divided into two parts for ease of understanding (Aesthetic dermatology and Dermatosurgery). We requested dermatologists who had finished their post graduation after 2010 to fill this questionnaire, which was circulated on online platforms like WhatsApp and Facebook. The findings of the same have been drafted and will be submitted for publication. This will help in better understanding of needs and requirements of procedural skill enhancement and learning in young dermatologists. Dear members

It has been a year since the new editorial board took over. Recovering post pandemic, the editorial board and the publishers have taken great strides in catching up to current publication standards and timelines. Standing on shoulders of giants, our former editorial boards, who have prepped up the journal to such heights, it's been a tough task to maintain and improve a PubMed indexed, internationally acknowledged journal, focused on a niche community of dermatologists and aesthetic surgeons.

The journal has SCImago Journal Rank Indicator of 2022 at Q3 (0.244). It reflects a journals, impact, and prestige with weightage to citations in a year compared to the previous three years. We strive to improve this and place us in the Q2 in the coming years.

Our journal metrics show a healthy trend with a time for first editorial decision at 23 days and 49 days from revision receipt and review. All articles if accepted are done so within 100 days. Our rejection rate presently stands between 40-50%. Only articles directed at readership of cutaneous and aesthetic surgeons are being accepted. We give preference to clinically oriented studies over experimental and animal studies. Articles pertaining to plastic surgery, maxillofacial surgery, vascular surgery, oculoplastic surgery etc., that are relevant to Dermatosurgery and occasional exceptional article on core dermatology topics with surgical implications are accepted for review. Clarivate indexing is a work in progress, and we shall reapply for it shortly.

Initiatives to improve the journal quality, author and readership satisfaction have been taken. A common grouse of late print publications had led to withdrawal requests and complaints. 'Ahead of Print' version of the articles referenced with their DOI has been implemented with over 60 articles placed as this on the journal website.

Symposiums to showcase a treatment modality or upcoming techniques and devices along with topic centric issues are planned and we plan to publish two such issues a year. With an effort to go green we have print issues with only original articles, invited articles, CME, and review articles. All other articles are published in the online issue with adequate referencing including their DOI. This is also reflected in print with referencing of the online only articles as well.

I am assisted with an excellent team of associate editors Dr. Bikash Kar, Dr Swapnil Shah, Dr Gulhima Arora, Dr Savitha Somaiah, and Dr David Pudukadan and very dedicated assistant editors Dr. Saurabh Singh, Dr Balkrishna Nikam, Dr. Eeshaan Ranjan, Dr. Manasa Jeanney, and Dr. Sivasankari. Their contributions and newer ideas and insights have been invaluable in



functioning of the journal office.

On behalf of the editorial team, I am extremely thankful to the support extended by Dr. Shyamanta Barua our ACS(I) president, Dr. Manas Puhan, Secretary General ACS(I) and Dr Debjit Kar (Treasurer) for allowing us to pursue that one goal we all have: 'Create new knowledge - publish the best research'.


